Title Page:

Title page contains title of the manuscript in bold face, title case (font size 14), names of the authors in normal face, title case (font size 12) followed by the address of authors in normal face, lower case (font size 12). Names of the authors should appear as initials followed by surnames. Full names may be given in some instances to avoid confusion. Followed by the author names, please provide the complete postal address or addresses with pin code number of the place(s), where the research work has been carried out. If the publication originates from several institutes, the affiliation of each author should be clearly stated by using superscript Arabic numbers after the name and before the institute. The author to whom correspondence should be directed must be indicated with an asterisk. At the bottom left corner of this page, please mention “*For correspondence” and provide a functional e-mail address of the corresponding author to whom all correspondence (including galley proofs) is to be sent

Abstract:

An abstract must accompany every article. It should be a brief summary of the significant items of the main paper. It should be informative and not only present the general scope of the paper but also indicate the main results and conclusions. An abstract should not normally exceed 250 words.

Introduction:

It should be a concise statement of the background to the work presented, including relevant earlier work, suitably referenced. It should be started in a separate page after key words.

Materials and Methods:

It shall be started as a continuation to introduction on the same page. All-important materials and equipments, the manufacturer's name and, if possible, the location should be provided. The main methods used shall be briefly described, citing references. New methods or substantially modified methods may be described in sufficient detail. The statistical method and the level of significance chosen shall be clearly stated.

Results and Discussion:

It may be combined or kept separate and may be further divided into subsections. This section should not contain technical details. Abbreviations and acronyms should be used sparingly and consistently. Where they first appear in the text, they should be defined;

authors may also explain large numbers of abbreviations and acronyms in a footnote on the first page.

Tables:

Authors should use tables only to achieve concise presentation or where the information cannot be given satisfactorily in other ways. Tables should be numbered consecutively using Arabic numerals and should be in the text itself at appropriate place not at the end or as separate attachment. Each table should have an explanatory caption which should be as concise as possible.

Figures:

Figures are numbered consecutively with Arabic numerals. Captions for figures should follow on the same line as the figure number and should be placed under the figure. Figures should appear within the manuscript when mentioned and should not be grouped at the end.

Original illustrations should be the actual size at which they are to appear in the journal. Color illustrations are encouraged. Each figure must fit one column on the journal page (maximum

3.33 inches) or, in exceptional cases, two columns (maximum 7 inches).

Lettering should be no smaller than 4.5 points (Helvetica or Arial is preferred). Lines should be no thinner than 0.5 point. Lettering and lines should be of uniform density.

Avoid artwork that includes complex textures and shading used to achieve a three-dimensional effect. If a pattern must be shown, choose a simple cross-hatch design.

Table of Contents Graphic:

Every manuscript must include a table of contents (TOC) graphic on the last page. The TOC graphic must be entirely original, unpublished artwork created by one of the coauthors, including any background photographs and clip art contained in the image. Also, because of its highly visible nature, care should be taken to ensure that the content of the TOC graphic is appropriate. Examples of potentially inappropriate content are smiley faces, cartoons, colloquial sayings, slogans, and so forth. The TOC graphic should be 5 cm x 5 cm in size and should capture the eye and curiosity of a broad spectrum of readers. The type size of labels and symbols within the graphic must be legible. The TOC graphic will appear as a graphical abstract in the manuscript, prior to the internal table of contents, as the TOC graphic in the electronic table of contents on the journal website, and as the individual TOC entry for this paper when it is retrieved via search. It may also appear as an image highlight on the journal website while the issue is current.

Equations:

Chemical and mathematical equations are denoted by Arabic numerals in parentheses at the right side [i.e., (1), (2), etc.] and should be numbered consecutively. Mathematical

equations must be typed and should be presented in the proper type style (i.e., italics, boldface, subscript, superscript, etc.)

References:

Please Note: For better observance of publishing ethics, the maximum number of references that any author can have in their research article is 40 references, and review article 500 references. All references should only include one reference and will not have a and b , (Date: October 1, 2021). This order is applicable from October 1, 2021 and does not include articles that submitted at prior to this date.

The list of references should only include works that are cited in the text and that have been published or accepted for publication. Examples of the *Journal of Medicinal and Chemical Sciences* reference style are shown below.

Types of paper

Regular articles: These should describe new and carefully confirmed findings, and experimental procedures should be given in sufficient detail for others to verify the work. The length of a full paper should be the minimum required to describe and interpret the work clearly.

Short Communications: A Short Communication is suitable for recording the results of complete small investigations or giving details of new models or hypotheses, innovative methods, techniques or apparatus. The style of main sections need not conform to that of full-length papers. Short communications are 2 to 4 printed pages (about 6 to 12 manuscript pages) in length.

Reviews: Submissions of reviews and perspectives covering topics of current interest are welcome and encouraged. Reviews should be concise and no longer than 4-6

printed pages (about 12 to 18 manuscript pages). Reviews manuscripts are also peer-reviewed.

Manuscript Charges & Fast Publication

New decision: *Note: Manuscripts that are submitted to International Journal of Advanced Biological and Biomedical Research during 2022-2023 will not be subject to any Article Processing Charges.
